

1. APAG Cosyst Group:

APAG Elektronik AG, a 100% subsidiary of APAG Holding AG exists since 1954 (founded in Switzerland). In 2008 APAG Elektronik AG acquired APAG Elektronik s.r.o (Czech Republic). In 2012, Kanoria Chemicals & Industries Ltd. (KCI) acquired APAG Holding AG. In 2015 the group was further expanded with the acquisition of CoSyst Control Systems GmbH. The group was restructured under APAG Holding AG and the three sister companies APAG Elektronik AG (ACH), APAG Electronik sro (ACZ) and CoSyst Control Systems GmbH (ADE) were re-branded together the **APAG Cosyst Group**. In 2018, APAG CoSyst Group starts a new Production and Development plant in Canada. The group drives to deliver excellence in its business to develop and produce electronic devices for automotive and industrial customers with their individual requirements.
